What is Telemedicine?





Telehealth is the use of digital technologies to deliver medical care, health education, and public health services...

Telemedicine, as defined by World Health Organization (WHO), is healing from a distance – allows the freedom to receive treatment without needing to schedule an appointment with your physician/mental health provider or go to their office to receive treatment.

Telehealth is the use of digital technologies to deliver medical care, health education, and public health services by connecting multiple users in separate locations and encompasses Telemedicine (diagnosis and treatment of illness or injury) – Healthit.gov

Commercial Health Plans: In the wake of the coronavirus, many commercial health plans have announced that they are making changes to copays and providing additional coverage for telehealth services. A list of insurances that have made changes can be found here on American Health Insurance Plans.

Some insurance plans may not always cover telehealth for all services or may charge a different rate for a telehealth service compared to an in-person visit.

It is essential for employees to double-check their coverage.

HIPAA & Telehealth: Office For Civil Rights (OCR) announced that it will exercise its enforcement discretion and will waive potential penalties for noncompliance with HIPAA when used in good faith for telehealth services related to COVID-19. This discretion empowers providers to utilize audio and video technology to serve patients responsibly for telehealth treatment and diagnostic. Covered health providers may use applications that allow for video chats, including Apple FaceTime, Facebook Messenger video chat, Google Hangouts video, or Skype.
